## **Highlights from the Business Department Report were:**

- As of 05/31/2018 income was \$3,667,357.23 with reconciled expenses through 5/31/2018 of \$2,271,310.91.
- Purchase of a 2018 Chevy Equinox to replace the 2006 Dodge Minivan using South Carolina State Lottery Money.

#### **Highlights from the Director Report** included:

- Review of buildings and grounds status included photos of the completed fence across
  the rear of the Summerville Branch. Door hardware needed to be in compliance with the
  fire code.
- Photos of the new Library vehicle were presented. Identifying magnets to be ordered.
- A catastrophic failure of an air conditioning unit within the Computer Server Room forced Director Antill to replace this unit using monies previously earmarked for an air conditioning unit at the Summerville location. The Summerville air conditioning unit will be replaced upon the receipt of three (3) quotes and, if necessary, Board approval.
- Reported that St. George Branch was fully staffed and Summerville branch will be fully staffed within two weeks.
- New staff welcomed: Diana DiSilva, Maxlin Bridge, and Jodi Lightfoot. Ms. Patricia Goodall, promoted from part-time Library Aide to part-time LAI.
- Annual statistics to be presented at the July 2018 meeting. General discussion of statistics ensued. General discussion about population expansion across Dorchester County.

Pemberton moved to approve the Technology Plan and Dr. McCarl seconded the motion
which passed unanimously.
